## RULES FOR USING PAID PARKING

### FEE PAYMENT PERIOD

Monday – Sunday 0 – 24 hours

### PARKING FEES, PAYMENT OF FEE:

The first 30 minutes from entry are free.

The parking fee is 440 HUF/hour, every 15 minutes started will be charged.

Daily ticket: 2000 HUF/vehicle

30-day pass: 8890 HUF/vehicle

In case of loss of the parking ticket, an administration fee is payable: 2000 HUF/ticket

Our prices are in HUF and include VAT (27%).

You can request an invoice for the payment of the parking fee from the customer service within 8 calendar days after the issue.

### TICKET EXCHANGE, PAYMENT

A parking ticket can be exchanged from the automatic ticket dispenser placed in front of the barrier at the entrance by pressing the green button. During this, the entry camera records the vehicle's license plate number. The driver must take the ticket from the device. Payment/exit is possible with this coupon. In case of loss of the coupon, an administration fee must be paid! Exit is done by reading the license plate number/scanning the ticket at the exit barrier after paying the parking fee.

The parking fee must be paid at the payment machine (CASA) before exiting. Payment methods: cash (coins/banknotes), bank card. After paying the parking fee, you have 10 minutes to leave the parking lot.

### RENTAL EXCHANGE:

A parking pass valid for 30 days, with unlimited use, can be exchanged at the CUSTOMER SERVICE office.

### GENERAL

By using the parking lot, the operator does not ensure the guarding of the vehicle, and is not responsible for the condition of the vehicle or for valuables/objects left in the vehicle.

The operator acts in accordance with the rules of civil law regarding the collection of fees. The parking regulations are valid from entering the parking lot to leaving the parking lot. In the event of a technical problem, the PORTÁN can ask for help.

The rules of the Road Traffic Act apply in the parking lot area.

The maximum permitted speed is 5km/h.

The operator may move or have vehicles removed in cases stipulated by law (e.g. force majeure). We cannot accept free parking with a disabled person's card on the property.
